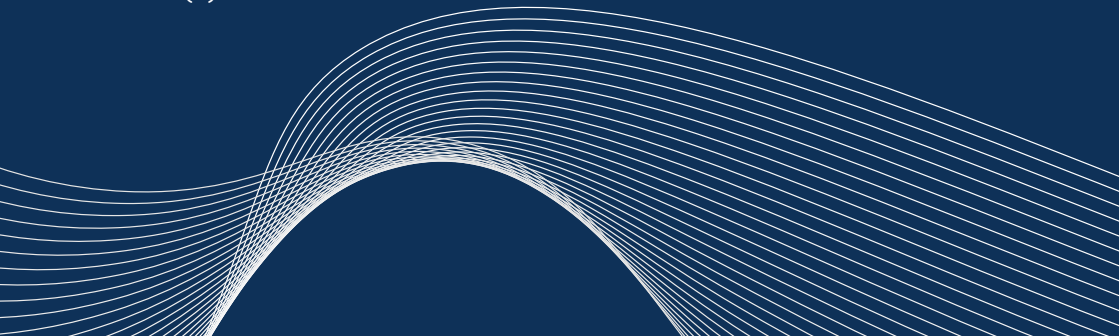

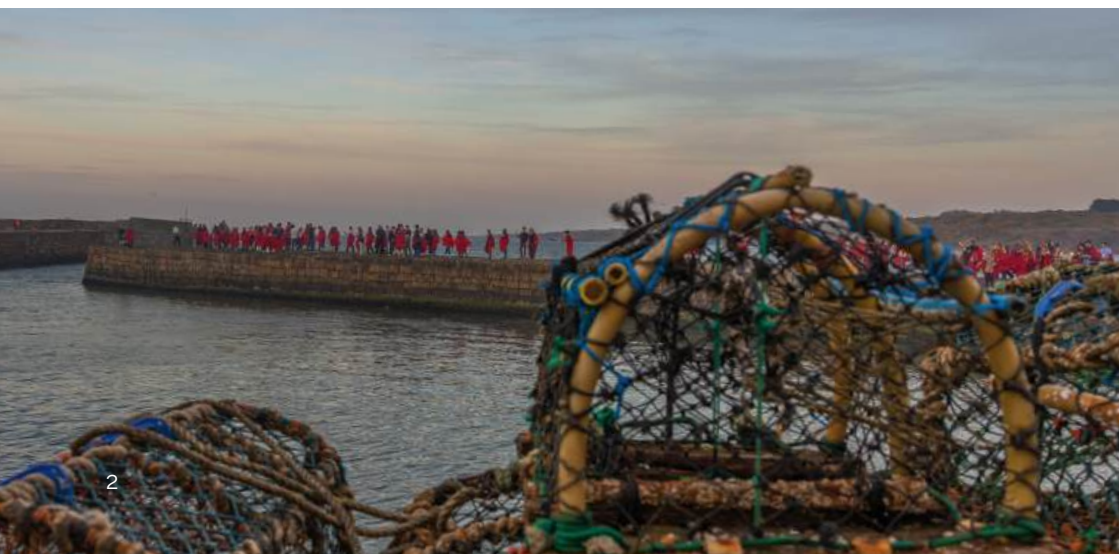
How to leave a legacy

The University of St Andrews American Foundation Inc. was established in 1985. Gifts to the University of St Andrews American Foundation are tax-deductible for US donors. Bequests for the benefit of the University of St Andrews can be made to the University of St Andrews American Foundation, which is a publicly supported section 501(c)(3) organization described in sections 509(a)(1) and 170(b)(1)(A)(vi) of the Internal Revenue Code and registered in the State of Georgia.

A gift in your will or naming St Andrews as a beneficiary of your retirement plan can reflect your personal interests, or you may wish to leave an unrestricted gift which will be used where need is greatest. We would be happy to work with you to help you plan the purpose of a gift that is appropriate for you. Leaving a legacy is straightforward and if you are thinking of leaving a gift to us our North American Team would welcome the opportunity to discuss your intentions to ensure that the University will be able to honour your wishes.

At the back of this booklet you will find a pledge form to let us know your intentions. You have our assurance that these will be kept confidential.

Once you let us know your wishes, we will be happy to welcome you to the Chancellor's Circle to recognise and celebrate your generosity.



How to word a legacy

We recommend you consult an attorney to draft your will. Your attorney should use the following form of words to suit your needs:

I give to the University of St Andrews American Foundation Inc., EIN 58-1662222, a publicly supported section 501(c)(3) organization described in sections 509(a)(1) and 170(b)(1)(A)(vi) of the Internal Revenue Code, c/o Alston and Bird, 1201 West Peachtree Street, Atlanta, GA 30309-3424, the sum of [in words] OR a [in words] percentage share of the residue of my estate OR my [detail your specific item or items] to be used for the general purposes of the said Foundation OR to be used for [detail the specific purposes you have] and I declare that receipt by the Trustees of the said Foundation shall be a full and sufficient discharge to my Executors and Trustees.

Declaring that:-

- (1) If the University of St Andrews American Foundation Inc. has changed its name or has amalgamated with or transferred its assets to any other body or has been wrongly designed then my Executors/Trustees shall give effect to such legacy or entitlement as if it has been made to such new or succeeding body or failing which to the University Court of the University of St Andrews (Scottish Charity Number SC013532), Fife, Scotland: and
- (2) Receipt by the Trustees of any succeeding body or the receipt of the Quaestor or other officer authorised by the Principal of the University of St Andrews shall be a full and sufficient discharge to my Executors and Trustees.'

It is also possible to name the American Foundation of the University of St Andrews as a beneficiary of your IRA, 401(k) or other qualified plan.

Your legacy can enable talented students to help change the world

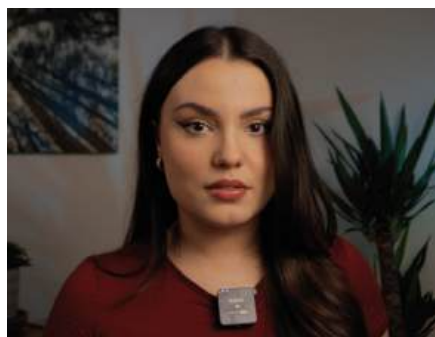
Scholarships have been at the heart of St Andrews since 1450, when a generous gift created four bursaries at the University. Since then, our aim has been to ensure that deserving students from all backgrounds have the opportunity to study here and become part of our unique community.

A scholarship enabled Nobel Prize-winning pharmacologist James Black to begin his university studies at St Andrews. With a gift in your will, you could inspire another passionate and talented student to play their part in helping to change the world.

Maria Andrei is one such student. Thanks to the Spragge Conservation Scholarship she is in the second year of a PhD in Computer Science with a research project that will hopefully contribute to solving climate change.

‘I am investigating how Virtual Reality (VR) can improve climate change communications and influence ecological attitudes and behaviour. Although climate change threatens many aspects of our lives, these threats are often perceived as distant because they are communicated in abstract ways, which inhibits pro-environmental behaviour. To address this psychological barrier, I am building climate VR simulations to illustrate how key regions across the globe will be affected by climate change and to enable people to experience and visualise the distant and future impacts of global warming in concrete ways.

‘The Scholarship has enabled me to reduce the hours in my part-time job so I can focus on my research, go on essential expeditions and travel from Dundee to the University’s PhD lab where I carry out my work. Thank you for making it possible for me to pursue my passion and help to solve climate change – humanity’s greatest challenge.’

Josh Cleaver is in the second year of the Scottish Graduate Entry Medicine (ScotGEM) course. The Gilian M Cucchini Memorial Scholarship has given him the financial stability to focus on his academic work – and the opportunity to explore where he can best make an impact in medicine in the future.

‘The support provided by the scholarship has not only helped with my rent but has also enabled me to subscribe to various revision websites and tools, and to make an annual subscription to an anatomy website, with access to a complete 3D model of the human body. This has really enhanced my understanding of human anatomy.

‘Before starting this course, I graduated with a first class BSc honours degree in Neuroscience from the University of Nottingham and was fortunate enough to have my dissertation published in the Journal of Molecular Neurobiology.

Neurology is an area of medicine I am very passionate about, and when I qualify as a doctor, I hope to remain active within this community.

‘As a result of the small-scale teaching we receive on the course, we have group discussions and debates about many different aspects of medicine – including global health. I’ve also become very interested in this and would like to pursue it in my future career.

‘Thanks to this scholarship, I’m looking forward to what the future brings.’

By leaving a legacy you could invest in world-leading research that changes the course of history. Legacies are a vital source of funding for projects of all kinds.

Health

Gifts in wills are helping St Andrews to lead the global fight against tuberculosis through new, safe and affordable treatments.

They are also helping to make technological breakthroughs – such as the development of a technique called ‘deep light imaging’ – that could revolutionise the diagnosis of many diseases including heart disease, eye conditions and cancer.

Dementia is a growing global health challenge. With the help of legacies, Dr Maggie Ellis at the School of Psychology and Neuroscience is helping people with advanced dementia who have lost the ability to speak.

Green transport

Legacies are helping to develop Scotland’s first hydrogen train. This project will reuse existing rolling stock to create new supply opportunities and skills creation for the emerging green economy.

Your legacy could also help to deliver critical data to reduce the environmental impact of sonar on the world’s oceans.

Global challenges

Through legacies we can provide flexible funding to our researchers when they need to react quickly to emerging global challenges.

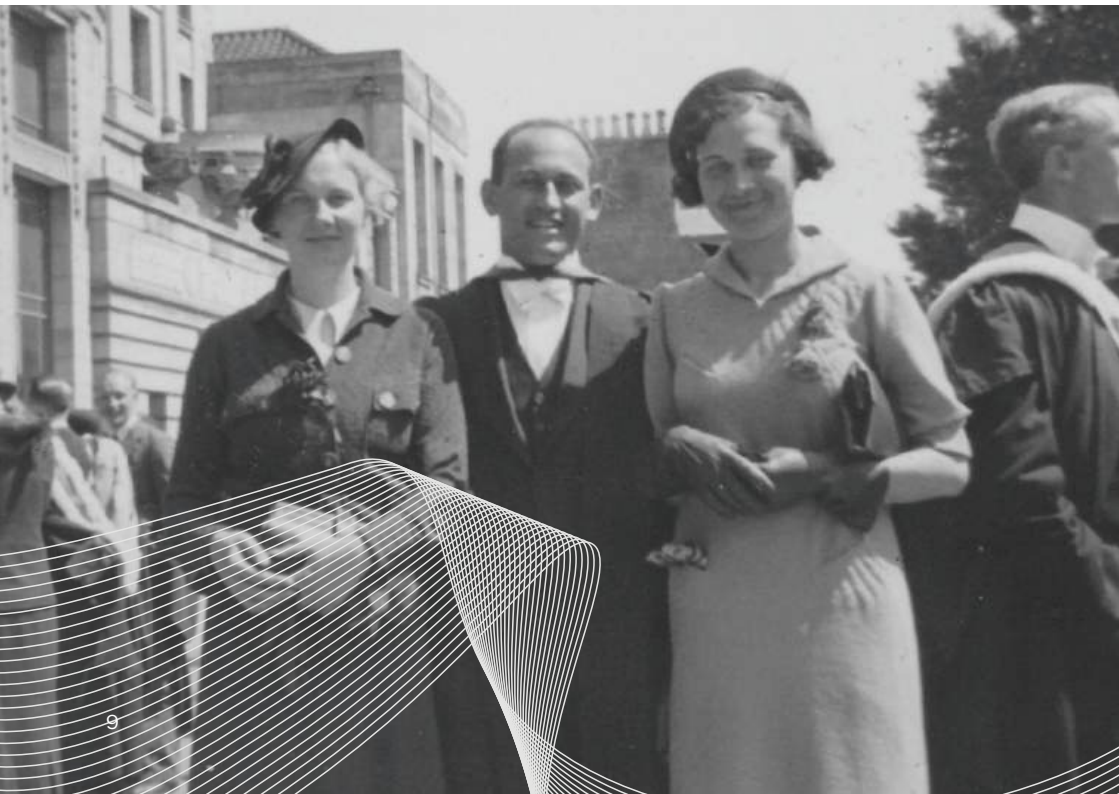
Your legacy can deliver a better future for us all

Dr Murray Fuhrman was one of a group of Jewish Americans who studied Medicine at St Andrews in the 1920s and 1930s, after they were barred from doing so in the US. His widow Silvia Fuhrman left a gift in her will in her husband's memory to thank the School for giving him this opportunity.

Thanks to her generous gift, the School was able to buy an automated system known as JESS. Using a technique called 'Western blotting' the machine can analyse proteins in human tissue more efficiently than other methods, potentially leading to new treatments for kidney cancer and other diseases.

Like Silvia Fuhrman, your legacy could help provide funding for a young PhD researcher at St Andrews who is working to address a global challenge – from climate change to healthcare.

The Byre Theatre

The [Byre Theatre](#) is home to, and a platform for artistic, creative, engaging and learning experiences that nurture and enrich the lives of our communities – both in St Andrews and beyond.

In addition, the Byre is committed to creating strong connections with diverse audiences through a programme of events including the annual Sands: International Film Festival of St Andrews, the StAnza International Poetry Festival and the St Andrews Playwriting Award, which is run in partnership with Playwrights' Studio, Scotland and Pitlochry Festival Theatre.



The Wardlaw Museum

The [Wardlaw Museum](#) gives visitors an insight into the institution that is the University of St Andrews. Its four thematic galleries feature the University's groundbreaking research and global impact, and showcase its extraordinary art, history, science and natural history collections.

These permanent galleries are complemented by an exciting programme of temporary exhibitions and interactive experiences for all ages, making the museum a major cultural space and destination.

Your legacy can redevelop an existing building

A legacy of any size will ensure that you become part of the fabric of St Andrews by funding the redevelopment of an existing building.

Scottish Oceans Institute

By 2016 Marine Science at St Andrews had outgrown its old home in the 'Gatty' laboratory on the East Sands. University Court approved its redevelopment, and work began on the new Scottish Oceans Institute (SOI) building that year.

The SOI was formally opened in September 2019. Since then, it has brought all our marine scientists under one roof and is facilitating daily interactions that are leading to innovative and cutting-edge research. The new aquarium is a facility of the highest quality and is being used to develop our knowledge and understanding of how human activities affect our oceans.

Sports Centre

Sport at St Andrews has one of the highest student participation rates of any university in the UK.

Following a major £14 million redevelopment of the Sports Centre – which included a substantial contribution from legacies – the University now provides some of the best sports facilities in the country. To remain competitive within the current landscape of University sport and to keep up with greater student demand we continue to have ambitious plans to develop our facilities.

Laidlaw Music Centre

It was thanks to a transformational donation from the Laidlaw Foundation and a significant bequest from the late Jean McPherson – in addition to many donations and legacies from friends, parents and alumni – that this wonderful, award-winning building is now at the heart of the University's music making.

The Music Centre is open to the entire community of Fife – not only to students and staff of the University. It is also committed to outreach and devises projects for schools – including StAMP – our award-winning brass music education project.

Each semester it curates or hosts (and live-streams) more than 70 performances at venues such as the McPherson Recital Room – the first chamber hall in the world with a reverberation chamber.

The Music Centre also enjoys mutually enriching relationships with its three ensembles in residence: the Scottish Chamber Orchestra, the Fitzwilliam String Quartet and the Wallace Collection.
