

## 1 How the University will make use of your personal data

1.1 The University is required to inform you how personal data collected by you will be used and to provide other information, including details of with whom personal data may be shared and your rights.

## 2 The identity and the contact details of the controller

2.1 University of St Andrews, College Gate, North Street, St Andrews, KY16 9AJ, Fife, Scotland, UK. The University is a charity registered in Scotland, No SC013532.

## 4 The purposes for which the University will make use of personal data

#### 4.1 Administering your Saints Sport Membership

Your personal data is used:


- by Saints Sport to set-up and administer your Saints Sport membership (including membership of an affiliated University sports club, Junior Saints membership); which will involve creating a member record; to register you with any relevant sporting associations or bodies; to manage any disciplinary processes/investigations instigated by a club, sporting association/body or the Athletic Union.
- by sports club(s) committee, including office bearers who are elected/appointed from the student membership you have.
- by third-party partner organisations who provide services in conjunction with, or on behalf of, Saints Sport.

The personal data, which will be collected from you will include:

- your name
- date of birth
- contact details (address, email, telephone number)
- photograph
- confirmation if you do/do not hold other Saints Sport/Sports Club membership types
- information about your child/children (name, date of birth, address, medical information, disabilities – Junior Saints Memberships only)

## 4.2 Providing you with services

Your details will be used to prepare for and to provide you with:





- services from Saints Sport and third-party partner organisations i.e., to take and manage bookings. Staff from Saints Sport and/or the partner organisation may use your contact details to advise if changes to any prior booking arrangements are required
- services/events that a club may offer, either on its own or through the University Sports Centre and/or any other third parties engaged by the club/committee to provide those services.

The personal data, which will be collected from you will include:

- information about your bookings including date, time, and the name of your class/course
- information about other people in your booking when you make a booking on behalf of other people including children.

## 4.3 Advising you of services


**Changes to Services**: we will contact you to advise if there are any changes to services and/or their availability.

**Saints Sport Memberships**: Saints Sport may contact you (via email and other electronic means e.g., SMS text) without your consent to advise you of new services and facilities that you may be interested in, where those relate to services and facilities you have previously purchased a membership for. If you do not wish to be advised of services or facilities, please advise staff at Saints Sport and arrangements will be made so that no similar communication with you will take place, until such times as you choose otherwise. In all other instances we will seek your consent before advising you of the services we offer.

Sports Club Memberships: Club committees may contact you to advise you of events/services that you may be interested in that are offered by a club of which you are a member. The University Development Office may reach out to alumni who were sports club members to advise of events that may be of interest, including club reunions, dinners and other events that are run from time to time, where that is in your and the University's legitimate interests. If you do not wish to be advised of events/services, please advise the relevant club committee member and arrangements will be made so that no similar communication with you will take place, until such times as you choose otherwise. Similarly, if you have no interests when as an alumni in being contacted about club events, please advise the University Development Office.

#### 4.4 CCTV

The Saints Sport facilities at University Park use CCTV cameras, for the protection of University property and resources, to provide a safe environment and for the purposes of crime prevention and





detection. Saints Sport may review CCTV footage to understand whether individuals have upheld conditions of membership and other rules/regulations that may apply to them, when using the facilities.

The University will retain customer/booking data for a period of 6 years, after which time records will be destroyed. CCTV footage will be destroyed (overwritten) after 30 days. Comment: CCTV will be deleted, video footage for performance analysis won't be.

CCTV footage may be made available to Police Scotland and/or insurance companies, where there are claims arising from vehicle incidents in University car parks, covered by CCTV facilities, and provision in the Data Protection Act 2018 allows for a transfer of imagery to be made.

## 4.5 Delivering film and photography

Fixtures, training, events, and activities may be recorded by Saints Sport for live streaming purposes – where filming and/or photograph is taken place there will be a notice at the event; if you do not wish to be filmed or photographed please contact a member of staff at the event, who may then advise where you can spectate without being filmed and/or photographed. If that is not possible you may opt to leave the event. Filming and photography may also be used to provide materials for our fixtures, training, events, and activities, which we use for promotional, coaching, education, sports analysis and/or developmental purposes. Again, prior notice of such will be given and you will have the opportunity not be filmed and/or photographed.

#### 4.6 Improving our services


If you provide the University with feedback about your experiences of Saints Sport, we will use that information to improve our services.

## 5 The legal bases for processing personal data

## 5.1 Saints Sport Memberships

#### Contract

Your personal data will be used to service the contract between members of Saints Sport or for
preparation for entry into a contract. The University makes use of CCTV footage for protecting
resources and safety purposes under its public task. Contract is the lawful basis used where use
of CCTV footage is made to understand whether conditions of membership have/have not been
breached; and to provide video imagery where members/teams have requested such for
coaching/sports development purposes.





## Consent

For the filming activities outlined at 4.5, above, consent is the lawful basis for the collection and
use of your personal data. Notices of filming are provided, and if you do not wish to feature,
members of staff are available to assist. If assistance is not possible you then have the option to
leave a venue, whilst filming is underway.

#### 5.2 **Sports Club Memberships**:

#### Contract

- When using your personal data to create and administer your membership, to provide you with club services and to alert you to events/services being offered by a club.
- Where personal details are exchanged with third party sporting bodies/associations for purposes
  of managing membership with those bodies, which may include supporting investigations as to
  whether policy/regulation/articles of association of such a body have been upheld or otherwise.

#### Legitimate interests

When using your personal details to advise you of alumni related sports club events. If you do not
wish to receive details of those, please contact the Development Office, at any time; and

- 7 The period for which personal data will be stored, or if that is not possible, the criteria used to determine that period
- 7.1 **Saints Sport Memberships:** The University will retain customer/booking data for a period of 6 years, after which time records will be destroyed. CCTV footage will be destroyed (overwritten) after 30 days.
- 7.2 **Sports Club Memberships:** Information about your sports club membership(s) will be destroyed 6 years after any subscriptions have ended. Clubs may keep information about sporting honours and achievements in perpetuity, to support, celebrate and promote the history and sporting achievements. The University Development Office may retain details of your membership of a club/(s) for longer, to provide alumni with details of news and events, as described.

## 8 Rights available to individuals

- 8.1 European and UK data protection legislation provides individuals with a number of rights regarding the management of their personal data, in relation to guests making use of University accommodation your rights are:
  - The right of access to your personal data, commonly referred to as a subject access request, which
    involves the following being carried out within a calendar month:
    - Confirmation that personal data is being processed.






- Access being given to your personal data (provision of a copy), unless an exemption(s) applies; and
- The provision of supplementary information e.g. an explanation of how your personal data is processed and who this is shared with.
- The right to rectification, which may involve:
  - The University working to correct any inaccuracies in personal data or to address any omissions, which may require personal data to be annotated to acknowledge that this is incomplete.
- The right to erasure (the deletion of personal data, in specific circumstances), which is commonly referred to as the right to be forgotten, which may involve:
  - The University destroying specific personal data. However, that right does not extend to guest registration records, as the University is required by law to collect and retain those details.
- The right to restrict processing, which may involve:
  - The University agreeing to stop making use of your personal data where those data are contested, in terms of accuracy.
- The right to data portability, which may involve:
  - The University providing you with a copy of elements of your personal data that exist in machine readable form that you have given to the University.
- The right to object. Individuals have the right to object to the University making use of contact details for direct marketing in such circumstances the use of personal data must stop when an objection is received.
- 8.2 These rights have to be met by the University and any other organisation that takes decisions about how or why your personal data is used. Details on how to access those rights are available from the University website, or you can contact dataprot@st-andrews.ac.uk.

## 9 Where the University asks for your consent to make use of personal data

- 9.1 Saints Sport may ask you for your permission to be contacted in the future, via any contact details you have provided to:
  - Provide you with details of services and offers where you receive communications about such
    you can opt to stop receiving those at any time, please contact Saints Sport; and
  - Ask you about your experiences as a member of Saints Sport, a user of the facilities provided by
    or through Saints Sport to help us improve the quality of our services and the experience of all
    Saints Sport and Sports Club Members.





9.2 Consent is optional. Individuals are under no compulsion to provide their consent, and where consent is provided, you will have the right to withdraw consent at any time, from which point the University's use of your personal data will stop.

#### 10 The right to lodge a complaint with a supervisory authority

10.1 If you believe that the University has not made use of your personal data, in line with the requirements of the law, you have the right to raise this first with the University (please contact the University DPO at <a href="mailto:dataprot@st-andrews.ac.uk">dataprot@st-andrews.ac.uk</a>) and then with the regulator i.e. the UK Information Commissioner Office's ("the ICO").

# 11 Contractual requirement to provide personal data and the consequence where no personal data are provided

11.1 In order to secure services as a member of Saints Sport or to secure club membership and access to the associated services/events, you must provide details about you and your preferred contact details in order to become a registered member.

#### 12 Revision of the Privacy Notice

12.1 This Privacy Notice will be reviewed at regular intervals. The review period will be approved by the University and recorded on the accompanying coversheet. Any significant change to relevant legislation, University policy or procedures primarily concerned with the protection of personal data may trigger an earlier review.

#### 13 Availability

13.1 This Privacy Notice will be published on the University website.
